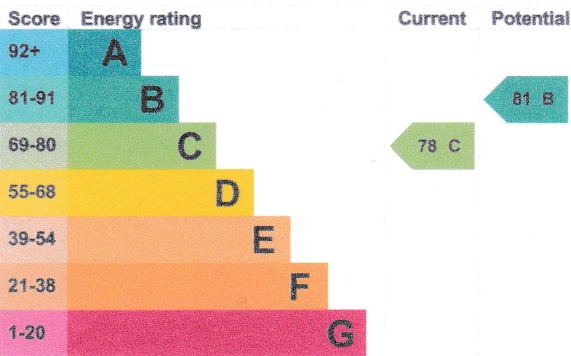

How this affects your energy bills

Type of assessment

RdSAP
